- 2. Street Repairs: Cotton Street: Rozell moved to table this item to the August 20th, 2024 meeting, Beahm seconded. Allen, Beahm, Fonteno & Rozell voted aye. Motion carried 4-0-0.
- 3. Street Repairs: Gilmer Street concrete slab removal and replacement: Fonteno moved to accept the bid from Pablo Sanchez to remove and replace the broken slab at a price of \$5,375 and Beahm seconded. Allen, Beahm, Fonteno and Rozell voted aye. Motion carried 4-0-0.

- 4. Volunteer Fire Department: Stipend for Chief: Beahm moved to approve a stipend of up to \$600 per month pending approval from the city attorney. Motion died for lack of a second. Beahm moved to research how to best proceed with compensation for the Fire Chief and to table this item for a future meeting. Rozell seconded. Allen, Beahm, Fonteno, Rozell and Sheeley voted aye. Motion carried 5-0-0.
- 5. City Administrator: Purchase of Generator for City Hall: Fonteno moved to award the bid for generator for the new city hall to Texas Certified Electrical for \$9,500 and Beahm seconded. Allen, Beahm, Fonteno, Rozell and Sheeley voted aye. Motion carried 5-0-0.

- 1. 2024-2025 Budget: The department heads presented their 2024-2025 budget proposals for General Fund (including the Police Dept.), the Municipal Dev. District, the Public Works Department, the Sanitation Department and the Volunteer Fire Department. No action taken.

- 7. Open Session: Public Works Director Job Description: The city council returned to open session at 10:08 a.m. Fonteno moved to approve the Public Works Director Job Description as presented granting 12 months to earn the required Class C Water and Wastewater licenses and Beahm seconded. Beahm, Fonteno, Rozell and Sheeley voted aye. Motion carried 4-0-0.

Beahm moved to post the position for 6 months or until the position is filled and Rozell seconded. Beahm, Fonteno, Rozell and Sheeley voted aye. Motion carried 4-0-0.
